FOLIAR APPLICATIONS:

Mix Guarantee Hi-K Seaweed Extract at the rate of 2-4 pints per acre per application. Use Guarantee Hi-K Seaweed Extract as many times as needed throughout the growing season. Guarantee Hi-K Seaweed Extract can be applied with most crop protection sprays.

SOIL APPLICATIONS:
